Go 2 blocks and turn left after you pass Warren Avenue into the Government Center parking lot (just before you get to the stop sign at Commerce Street).



## MG PROJECTS by Cy Haley

Below is a recap of the meeting we had covering the 2012 Projects. A list of the 2012 Unit Projects and a breakdown of the County projects can be found at 2012 NSVMGA Projects. A similar list for 2013 can be found at 2013 NSVMGA Proposed Projects. The 2013 projects have not had project applications submitted for them yet and are only proposed.

- Discussed the need for more accurate reporting of contacts. Determined that large
  projects/events, i.e. Farmer's Markets, Garden Fest, etc., will report contacts for the whole
  event and these are not to be reported on timesheets. The County Coordinator will need to
  make sure that the project/event leader does this. Individual volunteers will need to report
  contacts on their time sheets for projects that they do exclusively, i.e. speaking to garden clubs,
  lectures, etc. It will be the volunteer coordinator's and county coordinator's responsibilities to
  reiterate this to the volunteers.
- Cleaned up project list to be posted on the web site. (see attachment)
- All project applications are to be turned in to County Coordinators, who will evaluate them and
  if approved will forward them to VC Elizabeth Bevan. Elizabeth will further evaluate the
  application prior to sending to Dave Sutphin for his final OK before being submitted to VCE.
- Asked all County Coordinators to go over the procedures for reporting contacts and submitting project applications with the volunteers in their counties at the first meeting of the year.
- For the Unit projects, the County Coordinator for the county the event is to be held will be
  responsible for making sure the project application for that event has been submitted. This does
  not automatically make them responsible for the event, just for verifying the project application
  has been approved.
- Volunteers who will be doing individual projects (speakers, lectures, etc) are responsible for getting their project applications to the County Coordinator.
- Quarterly, Elizabeth will forward to Time Keeper Susan Garrett an updated project list for verification of projects listed on time sheets. If project applications have not been submitted the member will need to see that it is.

- A list of speakers in the Unit will be posted on the website and will be updated as more speakers are added.
- We will list the hours for Greenlines on the website for those counties that man desks at Extension Offices.
- Links to Monthly Tip sheets will be posted on the website for the public to access.
- Went over the procedure for possible Intern applications. They will go to Elizabeth who will
  confer with Mark Sutphin on the candidate's qualifications prior to the candidate being
  accepted.
- Interns will be instructed on information and use of the website with visual aids and hands on training (if available).
- Discussed recertification for 2013 and determined to post on member roster those who have recertified starting in 2013.

On Saturday October 20<sup>th</sup>, Frank Baxter, Skip Bowling, Sybille and Richard Stromberg, Katherine Rindt, Sue Rogers, and John Hunter spent several hours at the library planting shrubs that had been purchased and surrounding them with donated perennials. Local government crew had removed sod and put in top soil in the planting areas. One place where they had run out of top soil, the workers struggled to dig holes in the clay. The following Monday David Freese found places to plant the remaining perennials while the government put down mulch. It will be spectacular next year.

## **EDITORS CORNER** by Richard Stromberg

I had some nice surprises in my garden this fall (not including surviving Frankenstorm). First some Sweet Everlasting (Pseudognaphalium obtusifolium) appeared in the crummy, builders' soil next to the driveway. Sweet Everlasting is one of those Composites that has only disk flowers and never really opens, just pokes out some stamens. It is called "sweet" because it has a maple syrup smell when crushed. It is also called Rabbit Tobacco because the leaves can be smoked to help with respiratory problems. I have not crushed it nor smoked it. I was delighted to have a native plant appear. Another native appeared at the bottom of my driveway, Common Evening Primrose (Oenothera biennis). The yellow flowers come out at night and fade over the next day, but they keep coming, for over a month now. Below the Sweet Everlasting I noticed a Crocus blooming, a Saffron Crocus (Crocus sativa), not a native, but not invasive. I remember getting some bulbs at a MG monthly meeting a few years ago, but did not remember planting them where I saw them this year. Two years ago a friend brought my wife a vase with cuttings from her garden. Gradually they died away, but we nursed a Wandering Jew through two winters, putting the pot outside in the shade during the summer. This summer it put out the long, purple-leaved stem this house plant is known for. This fall it flowered, and the three-petaled flower reminded me that I had seen it a few years ago flowering in Gutamala, in Quirigua, one of the ancient Mayan sites. The color and form of the flower said to me, "Spiderwort", and indeed it is—*Tradescantia pallida*.

## **QUIZ OF THE MONTH**

Last month's question was, "What is the blue flower in the picture? After a few suggestions from various people, Mary Flagg came up with the answer: Princess Flower (Tibouchina semidecandra). When I asked how she figured out, she answered, "I have been looking for large blue/purple vines to plant.....this one was on my list."
